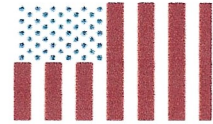

Subject: Formal Notification of The Indiana Assembly's Rejection to and Withdrawal from any Assumed Membership or Authority of the World Health Organization

Rejection of all The World Health Organization, International Health Regulations, Pan American Health Organization and all subsidiaries

Notice to Principal is Notice to Agent, Notice to Agent is Notice to Principal

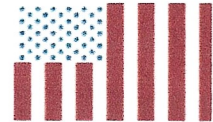
Greetings Director-General Dr. Tedros Adhanom Ghebreyesus or Successors and Assigns,

Indiana is not a member of the World Health Organization or any related entities. This order is protected by the American Federal Constitutions, Articles of Confederation, Treaties, Foreign Sovereignty Immunities Act, and Law of Peace. Any of your pandemic emergency, acts, declarations, statements or actions are not lawful on the land and soil on Indiana and are wholly rejected by the people on Indiana. All infringements are considered as an act of terrorism.

As our American Government is a Living Government and its sovereignty is firmly vested in the living people of The United States and exercised by the lawful Persons of The United States of America, there can be no offer of contradictory authority from any foreign subcontractor nor any incorporated entity or agency working on a For Hire basis nor on a Voluntary basis nor acting upon Assumption of any prior contractual relationship. All foreign subcontractors -unincorporated, corporate, and incorporated - and all federal subcontractors, federal, territorial, and municipal, together with all franchises and agencies thereof, are obligated to stand subject to our authority while proposing any action whatsoever in our behalf.

Notice to all WHO Enforcement agencies, agencies of the Federal government, check point administrators, Municipal and Territorial personnel and military personnel who have taken the oath to support and defend the Constitutions of the United States and United States of America are to secure these individuals natural and unalienable rights; additionally, hired contractors are to heed this order and other foreign agencies on Indiana. Any person attempting to inspect or force any medical procedures on any living man or woman on Indiana shall disclose their Name, personal contact information, jurisdiction, bond information, identification, and are commanded to not detain or hold the Indianan.

We hold the Second amendment right to possess unregistered firearms and ammunition. We will not fire on another human being unless we are in fear of our life and as a last resort to protect any other human life. We will come to the aid of any peace officers, and law enforcement officers (LEOs) should they

request our assistance. We are on the same side as the law enforcement agencies that lawfully enforce American Common Law. We claim full responsibility for our actions and do not seek limited liability privilege protection from any entity.

We hold the right to exercise our unalienable right and lawful right to travel, unhindered, and unencumbered, at our discretion. We are not operating commercial vehicles in commerce, subject to Statutory regulations and codes, but are private, Lawful Persons enjoying our unalienable rights. No infringement against any body such as forced vaccines, body fluid extraction, detention, Chemical Biological Radiation (CBR) agents, direct energy, frequency modulation, ultra-low/high frequency microwave propagation devices or similar methods shall be employed.

All contracts, including tacit agreements, require informed consent of both parties. Anyone who interferes with our lawful activities and unalienable rights after having been served notice of these claims, and who fails to properly dispute or to make a lawful counter claim, is breaking the law. The Fee schedule for the above is: A ten thousand (\$10,000.00) lawful dollar fee per hour (or portion thereof) will be charged to the officer and/or agency if interrogated or detained by any law enforcement officer conducting the business activity of revenue collection for its corresponding agencies of corporate government. A one hundred thousand (\$100,000.00) lawful dollar fee per hour if performed any medical acts, handcuffed, kidnapped, transported, incarcerated, or harmed in any way. A trillion (\$1,000,000,000,000.00) lawful dollar fee will be charged for each loss of life.

This rejection is immediate in this notice of understanding, notice of intent, and notice of our claim of right.
