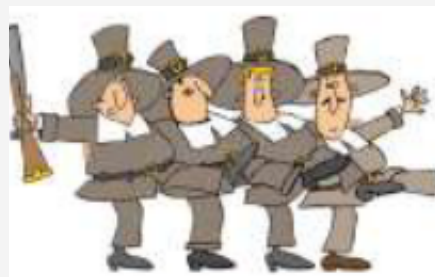
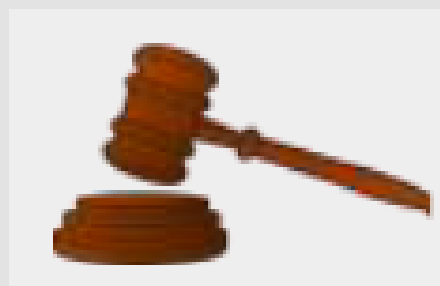


### Business/International Assembly

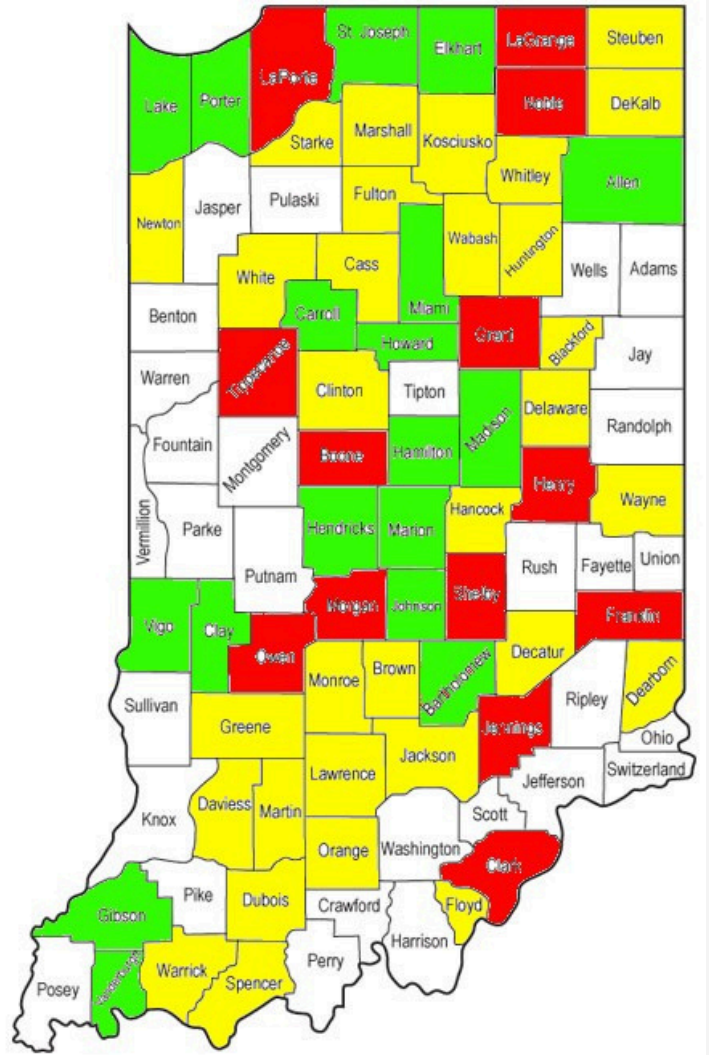

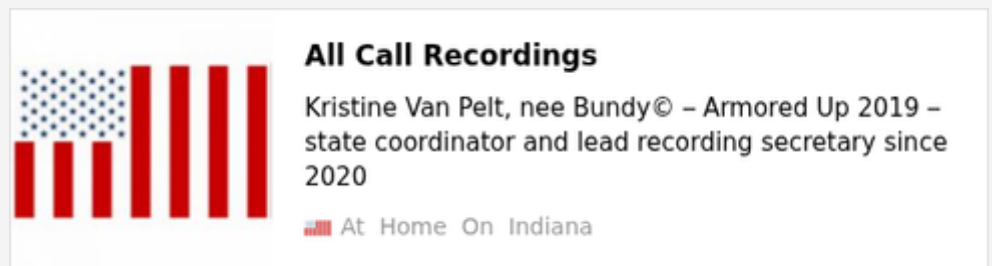

# Assembly Participation and Behavior Guidelines

## The Right to Peaceably Assemble

*"... The Summoning Authority bears the responsibility for the action, and must do their level best to make sure that each State Assembly is composed of properly declared and qualified individuals, that each State Assembly is properly structured and functioning with a General Assembly, International Business Assembly, Public Courts, and Militia, and that everyone is made aware of their rights, duties, and responsibilities---- whereupon the State Assembly is deemed to be fully seated. This we are endeavoring to accomplish, and as it hasn't happened in 160 years, we have started from scratch..."*

*From Article 3243 - "The Right to Peaceably Assemble"*



**The Civil Peacetime Flag**

The American people are not at war.

Our States and our Federation of States were never involved in the mercenary conflict known as the Civil War. It was fought completely by the Territorial and Municipal corporations within the air and water jurisdictions. The Land and Soil Jurisdiction has been at peace continuously and remains so to this day. That's why we fly the Civil Peacetime Flag instead of our wartime flag, Old Glory.

## Assembly Participation and Behavior Guidelines

*From Article 3022 - "Focus for Assemblies"*

Don't let new people come into your Assembly and commandeer it with their "ideas" about how things should be and how things should be run. **Nationality is a birthright. Assembly membership is a choice.** If they want to join, fine. Put them to work, but also set boundaries.



While we cannot deprive people of their birthright, we can and must throw disruptive people out of meetings and refuse to let them interfere with getting the work done. Participation in Assemblies is predicated on being polite and productive members of the community--- troublemakers and anarchists and the me-me-me people need to be disciplined, educated, and if need be, shown the door.

The Assemblies are business organizations engaged in very serious and important business. We have to "set the tone" for new members and establish the group values, so that the group as a whole disciplines people to be polite, logical, business-like, and mature. The moment anyone starts acting like a Seventh Grader and gossiping and being paranoid, it's up to the whole group to let that person know that that behavior pattern is not appropriate, not productive, not appreciated, and won't be tolerated. Shun gossip and fear-mongering and it will disappear.

## There is Only One Rightful, Lawful Assembly

Sure, anyone can assemble. But there can be only one actual, factual, rightful and lawful Assembly that is the foundational part of our American government. And you found us! This is the Assembly that has been summoned by the only legitimate Summoning Authority, The United States of America, our unincorporated Federation of States. Any other organization calling itself an Assembly is not recognized by the Federation and has no lawful standing as a part of the true American Government.

Though it hasn't quite hit home yet for many people, Incorporated organizations like LIFE FORCE, the Reign of the Heavens Society, the Kingdom of Hawaii, the Republik, the United States of North America, the Unity States of America (Russell Gould's operation) and similar efforts all represent foreign governments.

# You've Got Three Choices!

## The Three Assembly Choices:

### Choice One:

#### Join your American State Assembly

Stand up as an American and declare and record your political status as someone who is self-governing and owed all the Constitutional Guarantees and all proper exemptions, build up your State Assembly, and enjoy the protection of the Public Law. Be responsible for your American Government and its proper functioning. Live up to being worthy of independence.

### Choice Two:

#### Join the local District Assembly

Accept the status of a British Subject and agree to give up your land and other material possessions to the Queen to use as chattel property, relinquish your Constitutional Guarantees, agree to be counted as a British Territorial U.S. Citizen, and live under foreign Statutory Law, either as a Ward of the State or as an Indentured Servant. Give up responsibility for your government and do whatever you are told to do.

### Choice Three:

#### Join the local Municipal District Assembly

Accept the status of a Papist Municipal citizen of the United States, give all natural rights, titles and interests you have to the Pope, and agree to act as a slave belonging to the Roman Municipal Government. Be liable for all the debts of the US, Inc. and be subject to all Municipal laws, codes, and statutes, both written and unwritten. Give up all Constitutional Guarantees and all responsibility for governing yourself and do whatever you are told to do.

## Article 5021 Committee of the Whole Clarification for Militia

At the outset, after an individual has been advised of the facts and has made their declaration recovering their birthright status as an American, they have a choice. They can join their State Assembly or not.

Once they have made that decision and have joined the State Assembly, they have also accepted certain obligations as members and participants in the State Government.

If they are eligible to serve as State Citizens they are automatically considered members of the International Business Assembly as well as the General Assembly, and must show reasonable good cause for not serving in this capacity.

The same is true of the General Membership and the Jural Assembly. All members can be called upon to serve as Jurors and form two common law jury pools depending on the nature of each case to be considered --- whether the matter is totally within state borders, or is international in nature. Again, as State Assembly members we are obligated to serve unless we show good cause otherwise.

The same is true of the Militia. We are expected to participate unless there is good cause why our participation is not possible or ill-advised at a given time.

This element of duty which is not present in Common Committees means that each of these Four Pillars is in fact a separate Assembly in its own right.

Everyone who is eligible is expected to serve as State Citizens, if they can, as Jurors, if they can, and as Militia members, if they can.

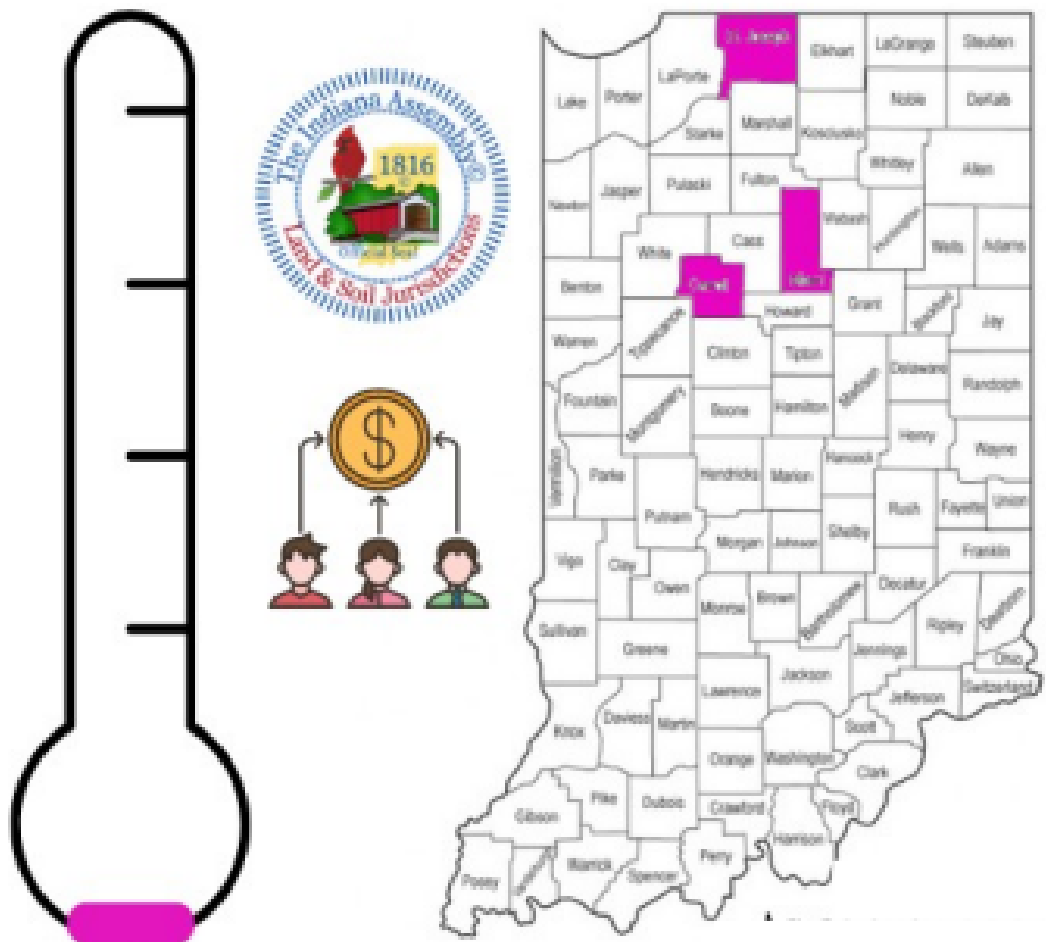

### American State National

#### Eligibility:

- ☐ 21 years of age
- ☐ Born on American soil, Naturalized, Green Card holder, or 7 years living here if undocumented.

#### Paperwork:

- ☐ 1779 One Page Declaration
- ☐ Birth Certificate
- ☐ 2 Witness Testimonies

#### Obligations:

- ☐ Obey the Public (non-statutory) Law
- ☐ Keep the peace

#### Limitations:

- ☐ Do not hold public office
- ☐ Cannot vote on international matters
- ☐ Can attend and express their views at public meetings only

**"State Nationals ...** are free of any obligation to the State Government except that they are obligated to keep the peace. This means that State Nationals enjoy the protection of the State and the enforcement of their Constitutional guarantees by the State, and so long as they don't harm anyone else or ruin or steal property belonging to others, they are free to live their lives and enjoy the peace.

**"For an adult to choose the status of State National usually implies some condition of need. People who are too old or too sick to fully participate, people who have overwhelming burdens at home, people who suffer from mental issues and addictions, people who are working for other governments, and all minors, are owed the status of State Nationals--- and our protection."**

### American State Citizen

State Nationals who choose to serve the State Government in some capacity, such as Jurors, Militia Members, elected officials, or hired officials.

#### Eligibility

- ☐ 21 years of age
- ☐ Born on American soil, Naturalized, Green card holder, or 7 years living here if undocumented
- ☐ Live on Home State at least 1/one year and a day
- ☐ Member of the Assembly in good standing
- ☐ No dual citizenship or divided allegiance to any other political entity or government (*Tribal governments, Foreign Nationals, or State-of- State or other foreign government allegiances through BAR registration, Real Estate License, Federal Insurance Agent License, Medical License, Commercial Driver's License, etc.*)

- ☐ 1779 One Page Declaration
- ☐ Birth Certificate

**A State Citizen holds a unique allegiance to their State of the Union, so as to guarantee as much as possible, no conflicts of interest on their part.** Unique means "singular". While participating as a State Citizen and acting as a member of a State Assembly you may not hold any other allegiance to any other government. Period. This prohibition applies to Tribal Governments, State of State governments, the U.S. Federal Citizenships, and more obviously foreign governments, like England, Germany, and France.

You can be either: (1) a State National or (2) a State Citizen.

Being a State National or a State Citizen does not necessarily mean that you qualify to be a State Elector. You can be part of the State Jural Assembly and serve as a Juror without being a State Elector. You can be elected to a Public Office, such as Sheriff, without being able to vote for yourself. This is because of the pesky issue of letting non-landowners vote on questions that only affect landowners, and therefore the requirement that State Electors be landowners.

### State Nationals, State Citizens and Electors

*From Article 1566 – "For All The State Jural Assemblies - 25 State Electors, State Nationals, and State Citizens," By Anna Von Reitz*

**State Nationals =** everyone born within the physical geographical borders of a State. A National has no particular duty to serve the State other than to obey the Public Law (Non-Statutory Law) and keep the peace.

**State Citizens =** those State Nationals who additionally choose to serve the State Government in some capacity, such as Jurors, Militia Members, elected officials, or hired officers.

**State Electors =** those State Nationals who own land in the State and meet other requirements such as legal age, etc., to participate in State Elections.

- **Required: 3 wet ink originals of Status Correction documents**-1779, 928s, Common Carry Declaration, Declaration of Political Status, and Fee Schedule - All receive Assembly seals, 1 set returned to Indianan, 1 remains for State Assembly's copy, and 1 remains for County Assembly's copy. **Note:** The County Assembly is **NOT** the COUNTY OF COUNTY RECORDER.
- Documents that are Not Federation Approved Templates, or Altered/Modified beyond the personal details, or include any Territorial (such as 'USMOI') or MUNICIPAL verbiage will be Rejected as they are not included in the Federation Approved Templates.
- Documents presented with any form of Parse Syntax, including :John-Mark: Doe. or the use of 'i,' in place of 'I,' will be Rejected. See list of common Anna Articles later in this News Letter.
- Documents presented with an 'additional Notary page,' or ST OF ST Notary signed to an Assembly Recording Secretary or Assembly Public Notary block will be Rejected, as they are not acting in that capacity. Anna, and the law team, spent a great deal of time to create as many 1/One-Pagers as possible to include the Notary block, keeping it as simple as possible.
- A complete presentment of each of the Notices includes:
  - VOTER Registration-copy of Cancel Voter Registration sent to all places Registered and Voted, to include either copy of Postage Paid Receipt(s) or stamped copy from walking in to a COUNTY office to Cancel.
  - IRS-DC and NY-copy of dated and autographed letter, does **not** need thumbprint or notary.
  - Military-copy of dated and autographed letter, does not need thumbprint or notary.
  - **Notes:** Should be sending preferably Registered Mail, or Priority Mail, which would provide a Postage Paid Receipt. Should be using Postage Stamps (**note:** Forever Stamps are for US citizens) to pay, you have to hand to the Postal Worker, then get a Receipt. If using Postage Stamps without additional service(s), still hand to the Postal Worker and ask for Tracking Receipt. This will give a Receipt that confirms delivery is in transit.

### dull (adj.)

c. 1200, "stupid, slow of understanding, not quick in perception;" also, of points or edges, "**blunt**, not sharp;" apparently from Old English *dol* "dull-witted, foolish," or an unrecorded parallel word, or from Middle Low German *dul* "foolish, reckless," both from Proto-Germanic *\*dulaz* (source also of Old Frisian *dol* "reckless," Middle Dutch *dol*, *dul* "stupid, foolish, crazy," Old Saxon *dol*, Old High German *tol* "foolish, dull," German *toll* "mad, wild," Gothic *dwals* "foolish"). This sometimes is conjectured to be from PIE *\*dhul-*, from root *\*dheu-* (1) "dust, vapor, smoke," which also produced words for "defective perception or wits, turbidity of the mind" (compare Greek *tholos* "mud dirt," Old Irish *dall* "blind").

**Dull.** Ineffective for the purpose aimed at, wanting in life. A *dull* edge is one that will not cut ; a *dull* understanding, does not readily apprehend ; a *dull* day is wanting in light, the element which constitutes its life ; *dull* of sight or of hearing is ineffective in respect of those faculties. [Wedgwood]

From late 12c. as a surname. Rare before mid-14c. Of color "not bright or clear," from early 15c.; of pain or other sensations, "not sharp or intense," from 1725. Sense of "not pleasing or enlivening, uninteresting, tedious" is from c. 1400. Related: *Dullness*.

*dull.* (8) Not exhilarating; not delightful; as *to make dictionaries is dull work*. [Johnson]

### dull (v.)

c. 1200, "to lessen the vigor, activity, or sensitiveness of" (transitive), from **dull** (adj.). Of pointed or edged things, "make less sharp, render **blunt**," from late 14c. Of colors, glass, etc., "remove the brightness or clearness of," late 14c. Intransitive sense of "lose vigor, intensity, or keenness" is from late 14c. Related: *Dulled*; *dulling*.

### sharp (adj.)

Old English *scearp* "having a cutting edge; pointed; intellectually acute, active, shrewd; keen (of senses); severe; biting, bitter (of tastes)," from Proto-Germanic *\*skarpaz*, literally "cutting" (source also of Old Saxon *scarp*, Old Norse *skarpr*, Old Frisian *skerp*, Dutch *scherp*, German *scharf* "sharp"), from PIE root *\*sker-* (1) "to cut" (source also of Lettish *skarbs* "sharp," Middle Irish *cerb* "cutting").

The figurative meaning "acute or penetrating in intellect or perception" was in Old English; hence "keenly alive to one's own interests, quick to take advantage" (1690s). Of words or talk, "cutting, sarcastic," from early 13c. Meaning "distinct in contour" is from 1670s. The musical meaning "half step above (a given tone)" is from 1570s. Meaning "stylish" is from 1944, *hepster* slang, from earlier general slang sense of "excellent" (1940). Phrase *sharp as a tack* first recorded 1912 (*sharp as a needle* has been around since Old English). *Sharp-shinned* attested from 1704 of persons, 1813 of hawks.

### sharpness (n.)

"state or character of being *sharp*; keenness of edge or point; intellectual shrewdness," Old English *scearpnis*; see **sharp** (adj.) + **-ness**. "Ancrene Riwe" (c. 1200) has *scharp schipe* ("sharpship").

### sharpen (v.)

late 14c., *sharpenen*, "intensify;" mid-15c., "make a point *sharp* or sharper," from **sharp** (adj.) + **-en** (1). Related: *Sharpened*; *sharpening*. The older verb was simply *sharp* (Middle English *sharpen*), from the adjective and partly from Old English *gescirpan* (West Saxon), *scerpan* (Anglian) "to score, scarify;" also compare *scearpung* "scarifying."

To *sharpen (one's) pencil* in the figurative sense of "prepare to get to work" is by 1957, American English.
