- Is there any response to the Bivens Decision?

*Bivens v. Six Unknown Named Agents*, 403 U.S. 388 (1971), was a case in which the [US Supreme Court](#) ruled that an [implied cause of action](#) existed for an individual whose [Fourth Amendment](#) freedom from unreasonable search and seizures had been violated by the [Federal Bureau of Narcotics](#).<sup>1</sup>

  - "We, the members of the Indiana Assembly, in order to ensure peaceful and orderly meetings hereby establish the following Protocols: 1. All those wishing to speak to a topic, wait their turn and let the prior speaker finish without interrupting. 2. Each speaker is allowed three minutes. If a topic can't be discussed in three minutes, it needs to be addressed in a committee setting or be set up as an Agenda Item prior to the meeting. 3. All cussing, swear words, foul language, threats, and other inappropriate speech is not allowed here; this is a business organization and we expect all members and guests to act in a business-like manner."
- You are responsible for keeping the peace and upholding the Public Law. Use common sense and self-govern!
- 5021. Committee of the Whole Clarification for Militia <http://annavonreitz.com/clarificationformilitia.pdf> - The missing word is "functions". **Once they have made that decision and have joined the State Assembly, they have also accepted certain obligations as members and participants in the State Government. If they are eligible to serve as State Citizens they are automatically considered members of the International Business Assembly as well as the General Assembly, and must show reasonable good cause for not serving in this capacity.** The same is true of the General Membership and the Jural Assembly. All members can be called upon to serve as Jurors and form two common law jury pools depending on the nature of each case to be considered --- whether the matter is totally within state borders, or is international in nature. Again, **as State Assembly members we are obligated to serve unless we show good cause otherwise**. The same is true of the Militia. **We are expected to participate unless there is good cause why our participation is not possible or ill-advised at a given time.**
- **Floor Etiquette - How to request the floor:**
  - May I or raise Hand Icon (wait for the moderator to acknowledge you)
  - State your name and County
  - Present the information short and to the point. Keep it to under 3 minutes. Keep discussion to business topic (stay on point)
  - When you are finished yield the floor
- **Motions etiquette (follow floor etiquette to request the floor)**
  - 1) Motion on the floor (should be visible to read)
  - 2) Someone must second the motion in order to proceed to step 3
  - 3) Discussion on motion
  - 4) After discussion Call for vote/amendment (anyone)/kill
  - 5) Any Yea/Nay/Abstain (there is no need to justify your "vote")

**General Assembly Chair-pro tem** – ASC – Are You interested in Standing Up to Volunteer for this Elected Role?

**Marshal At Arms-pro tem** – ASC – 33 States have their M@A in place!

- **Description:** The Marshal at Arms ensures the safety and decorum at all meetings and events, providing safety and security of the meeting place itself and the people at the meeting. He or she trains others to handle the security of all the Assemblies and the people who work for the Assembly. He or she cares for the flag and works with the Elections Committee to secure ballots. The Marshal at Arms serves all 4 pillars of the Assembly - all meetings, all people. He or she can appoint and train others to assist with various duties, but the responsibility remains with the Marshal. A state level Marshal-at-Arms receives training from Federation level Continental Marshals, and county level Marshals in turn receive training from State or Federation level Marshals. A State level Marshal serves as a "committee chair" for all of the County Marshals at Arms as a collective. Or, think of it this way: every county level Marshal at Arms becomes part of a state level team or "committee of the Whole, Marshal at Arms" for which the State Marshal at Arms acts as "chair". The Marshals all work together, sometimes even with the Federation Marshals to handle larger security issues.
- **Eligibility:** The Marshal at arms position is an American State Citizen position, which requires completion of the 928 documentation package, no dual citizenships and no licenses that create divided allegiances.
- **Vetting:** This position is vetted by a Federation level vetting team that includes at least one Continental Marshal.
- **Requirements:** ⌚ Knowledge of public safety procedures ⌚ Firearm competency ⌚ Communication skills that include the ability to diffuse heated situations ⌚ The means to travel easily to areas requiring protection (a working car for example)

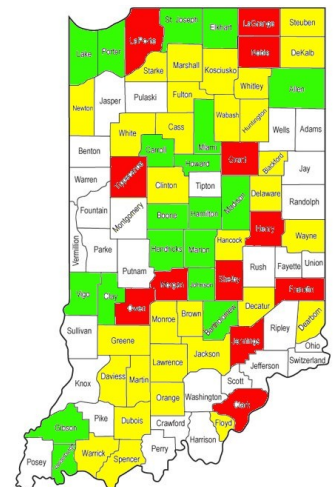

- Family plans for safely exiting house in case of fire or other necessity.
- A "reconnect" plan -- how they will locate each other if they have to leave their home, if telephone services are shut down, etc.
- Safety and First Aid Kit
  - two emergency "blankets" that reflect body heat for each member of the family and one for pets, adequate gauze, medical tape, saline solution, padding to dress multiple wounds large and small multiple times, band-aids, a range of antibiotic and antifungal sprays and creams, elastic bandages for sprains, anti-diarrheal medicine, laxatives, water purification tablets and Life-straw water filters for everyone, safety matches, candles, needles, microfilament, pain killers, scissors, sharp knife, tweezers, cold symptom medicine for fevers, antihistamine medicine, rubbing alcohol, and pure grain alcohol like Everclear, a hot water bottle/cold compress, basic vitamins, especially Vitamin C.
  - This will pack up in one or two small backpacks, depending on the size of the family, and be ready to go.

      2. Ignorantia Juris Non Excusat: This maxim means "ignorance of the law is no excuse." It implies that everyone is expected to know the law, and being unaware of a law does not exempt one from its consequences.
      3. Nemo Tenetur Se Ipsum Accusare: This maxim, often referred to as the privilege against self-incrimination, means "no one is bound to accuse himself." It is a fundamental principle in many legal systems, protecting individuals from being compelled to provide evidence that could be used against them.
      4. Res Ipsa Loquitur: Meaning "the thing speaks for itself," this maxim applies when an accident occurs in circumstances where it is unlikely to have happened without negligence. It shifts the burden of proof to the defendant to demonstrate they were not negligent.
      5. Respondeat Superior: This Latin phrase translates to "let the master answer." It means that an employer is liable for the actions of their employees performed within the scope of their employment.
      6. Audi Alteram Partem: This maxim, meaning "hear the other side," is a fundamental principle of natural justice. It requires that both sides of a dispute be given a fair opportunity to present their case before a decision is

made.

7. Ex dolo malo non oritur actio: This maxim, meaning "an action does not arise out of fraud," signifies that a claim based on deceit or fraud will not be upheld by a court.

8. Expressio unius est exclusio alterius: This maxim, meaning "the express mention of one thing implies the exclusion of another," suggests that if a law specifies certain things, it implies that other things not mentioned are excluded.

9. Ubi jus ibi remedium: Meaning "where there is a right, there is a remedy," this maxim indicates that for every legal right, there should be a corresponding legal means to enforce that right.

10. Stare decisis: This principle, meaning "to stand by things decided," is a cornerstone of common law systems. It emphasizes the importance of adhering to precedents set by previous court decisions.
