- Is there any response to the Bivens Decision?

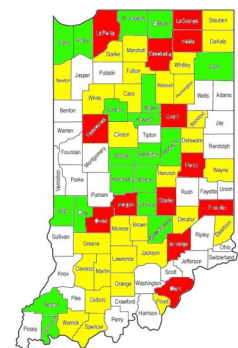

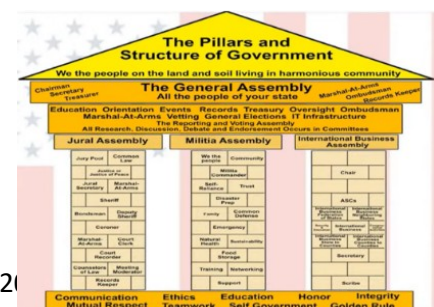
